Declarations of Interest Summary

All councillors are required by law to complete a Declaration of Interests form to register their financial and other interests that could potentially conflict with their role as local councillor. They are also required to declare any interests at the start of any council meeting where that particular interest conflicts with some or all of the business to be discussed at that meeting. They may not take part in the discussion of or vote on those items in which they have a prejudicial interest.

This document summarises the Declaration of Interests forms submitted by Purley on Thames Parish Councillors. Where "None" entries have been made these have been omitted. The actual statements can be viewed at the Parish Offices during normal opening hours by appointment with the Clerk.

Councillors - Registration of Interest

All Councillors on the Parish Council, are required by law to complete a Register of Member's Interests form to register their interests and those of their spouse, partner or civil partner. Failure to declare any known interests is a criminal offence.

Registrable interests include details of any employment, trade or profession; interests in any land in the area; names of any companies, corporations or societies active in Purley on Thames in which they have a substantial interest; membership of any bodies such as other public authorities, political parties, charitable organisations; and details of any outside bodies to which they have been nominated by the Council.

A full description of registrable interests is set out in the Code of Conduct for Councillors, together with details of how and when members must declare interests at council meetings.

Under the Code of Conduct, members must also declare in writing any gifts or hospitality with an estimated value of £25.00 or more that they receive in their role as a member. They need to declare them within 28 days of receiving them. The Clerk to the Parish Council holds these written declarations on file and they are available for inspection by appointment.
